## Chairman's Report 2019

I would just like to start by saying how proud I am to be your Chairman and to be part of such a lovely committee. We are all volunteers and give up many hours to plan and run the numerous events throughout the year for you, our members. One of the first meetings of the year is our schedule meeting where we try to plan which events we are going to be holding throughout the year, the classes we are including in them and possible dates. This year we have given the website a make over to make it more user friendly and informative for you; I'd like to thank Gemma Gale for doing this.

I'd like to say a big 'thank you' to all our lovely members who helped to put the show jumps out at the beginning of the year. The weather was kind to us and there has been either a show or a clinic throughout the whole of the year, either on the Club field or at Wix Equestrian Centre.

This year we have run many clinics with a variety of instructors. Please remember that these are for both the juniors and seniors; you will be put into groups accordingly as best as possible or, of course, you can ask for individual instruction. I certainly enjoy attending a clinic and value the support the instructor offers me, so I am extremely pleased that these are now offered regularly again. We just aim to cover the costs and believe this is one of the perks of being a member of this club.

Showing: We introduced a showing clinic at the beginning of the year which proved popular. There was an in-hand and ridden group and Lynda Calcutt instructed. We had some lovely feedback and it was great to see some of the people competing at our showing shows throughout the year. Not only did Nicki Lush run Spring, Summer and Autumn showing shows, but Angela Bush also introduced an in-hand showing show which was well supported along with our yearly novice show.

The Annual Show is always one of our busiest shows of the year and has many trophies presented associated with the classes. We raised an amazing £1030 in sponsorship alone and a huge thank you must go to all the kind sponsors and Gail Oliver who

dedicates many hours to contact them. Well done to Lorraine Green for organising the Annual Show too.

Dressage: The intro and prelim classes are always very busy, but Jo Mason works hard to provide a variety of other classes to cover all levels of dressage which our members are competing at. Jo also introduced a Prix Caprilli class. If you saw me competing in this, you would have laughed as Spider jumped so big over 18" jump and then put in a huge buck and I nearly landed in Mary's lap in the judge's box at Wix! But I did stay on!! Another first for this year was team dressage show at Wix which was very successful with thirteen teams taking part.

Show jumping: We are very aware some members are happy to jump the 45cm and 60cm classes and would like to be able to stick at these heights. Therefore, this year we introduced an open section for these heights, thus enabling those competitors who have never won two firsts at this height to be able to compete with others in a similar position, but those that have won at these heights can then compete but in the open section. This proved very popular, this was also followed through with the Arena Eventing. Lorna Simpson and Carol Chisnell, our President, run these shows.

Congratulations must go to Lorna who stormed to victory just last week in the Dodson and Horrell 95cm Amateur **National Championship** Finals at Aintree on her very own Zilver Bling. This was out of 145 competitors. If you want to learn how to shave a few seconds off against the clock, you only need watch Lorna ride at one of our shows to watch how it is done!



## Chairman's Report

Inter-Schools show jumping is always popular and makes a lot of money, but we all have to work hard, and it is a very long day; thank you again to Lorna Simpson for organising this.



**Gymkhanas** and Junior Rallies: It would be lovely to see more people attending these. They are supported by our more junior members, some of which are on lead rein, therefore costs are kept at a minimum.

I love watching how these younger members progress and gain confidence throughout the year and feel it is important to keep these going.

Like many organisations, when some of us are running a show we go to people who have helped before; this can sometimes make it seem like a closed circle where others are not welcome. Please do not think or assume this is so; if you can spare a few hours on the date of a show please contact the organiser and let them know you are available to help and I am sure they will be very grateful for the offer.

One of the benefits of being a member means that you can hire the field for a nominal fee. If you do break or damage a pole or jump, please let us know so we can replace it. I promise you won't be charged for the damage or told off but it does mean that we can replace it; otherwise Anna spends hours walking around the field trying to find a missing pole that goes with a particular jump she is building for one of our shows.

This year, we became aware that even though we have owned the field for many years it has never been officially registered with the Land Registry

Office. We are now in the process of completing this.

We all know that 280 houses have had outline planning permission passed alongside our Riding Club field. I would like to reassure you all that we have a right of lawful use to use our field throughout the year and plan to continue to do this. We are looking at possibly moving some of the rings around and trying to improve the going in the warm-up area. We did manage to paint the judge's and collecting ring boxes but next year I would like to paint the secretary's cabin and, hopefully, replace our toilets.

Unfortunately, I cannot name everyone that has helped at our shows throughout the year. From taking entries, putting up poles to stewarding and everything else; you know who you are, and I appreciate all your support. I would like Anna and Sarah to come up to receive a gift; Anna builds our show jumping course and Sarah gives up many hours to provide first aid cover at our shows.

As Chairman, I am very grateful to have such a lovely committee helping me along the way and I would like all the committee members to stand up and for you to join me in showing your appreciation for all the hard work and time they give up to run our many shows.

## Treasurer's Report 2019

The last twelve months have remained financially unsteady for the majority of the equine community with many other equestrian clubs seeing losses in competitor numbers at shows.

Income for Tendring Hundred Riding Club mainly came from shows, the gymkhanas, clinics, and our junior and senior teams. The Club managed to run a very successful series of shows during October 2018 until September 2019 with the shows' income being up 46% on last years amount. A total of £13,713.44 was brought in from Show Jumping, NSEA Inter-Schools Show Jumping, Area 8 Show Jumping, Dressage, Showing and the Annual Show. With clinics now being held at Wix Equestrian Centre alongside the Club field, the Club has seen an increase in 92% of income from clinics.

We were very lucky this year as a club to be blessed with such good weather the majority of the time, allowing all the shows to run successfully. However, the gymkhanas' and rallies' income, unfortunately, due to extreme weather conditions, was down 42% on last year.

Membership income was up £600 from last year.

Unfortunately this year we were unable to secure a Club camp due to a variety of reasons. We are hoping that 2020 proves more fortunate.

To help cover costs this year, the Club's junior and senior team riders have been helping to finance their team's costs. However, the Club now is able to financially help towards a portion of the costs at the championship shows.

The Club has certain fixed overheads and everincreasing costs but, this year, the majority of the Club's expenditure has been put into rosettes, sashes and trophy updates and repairs

as well as some other purchases. With money in the bank from last year's accounts the Club purchased a new tannoy system, paint for improving the cabins at the Club field, and new jump sets.

These purchases



totalled £2,136.97. The Club also put committee members forward to complete their first aid training.

Our clinic costs have also been higher this year to pay for the instructors and the hire of Wix Equestrian Centre. Although, just to mention, clinics overall did see a profit.

Last year's Annual General Meeting and Prize-Giving function cost was £810.96, which was the reason behind trying somewhere new for 2019.

After increasing insurance costs last year we were able to source a better deal whilst still retaining all the insurance required. We have managed to save the club nearly half of last year's cost.

Overall this sees Tendring Hundred Riding Club into a healthy profit at the end of September 2019 of £6,089.21 Future ventures include investing further in the toilet block and updates to the club field.

We ended the financial year with £12,979.71 in the bank.

# The Minutes of the 50<sup>th</sup> Annual General Meeting of the Tendring Hundred Riding Club

Saturday, November 23<sup>rd</sup>, 2019 @ 7.00pm Weeley Village Hall

#### 1. Chairman's Opening Remarks

Alison Power, Chairman of the Tendring Hundred Riding Club, welcomed all members to the Annual General meeting and thanked them for attending.

#### 2. Apologies

Apologies were received from Gemma Gale, Emma Brine and Rebecca Robinson.

### 3. Approval of the minutes of the 49<sup>th</sup> Annual General Meeting held on 23<sup>rd</sup> November 2018

The Honorary Secretary, Angela Bush, read the minutes of the 49<sup>th</sup> Annual general Meeting from 2018. The minutes were approved unanimously.

#### 4. Matters arising from the minutes

No matters were notified.

#### 5. Chairman's Report

Alison Power, Chairman, read the Chairman's Report. The report was detailed; the following highlights were noted from the year:

- THRC members are greatly valued for all their volunteering at club events
- The clinics were very popular and offer excellent subsidised training for THRC members
- Sponsors of the Annual Show were thanked for their generosity
- Each discipline was summarised, and the organisers thanked for their commitment to running these
- Members were reassured that although outline planning permission has been passed for 280 houses adjacent to the THRC field, THRC has a right of lawful use and will continue to use the field throughout the year
- The Committee were thanked for all their hard work

The Chairman presented gifts to Anna Deville for building the show jumping courses and Sarah Alliston-Austin for providing first aid cover at many of THRC's shows.

#### 6. Treasurer's Report

The Honorary Treasurer, Jenna Davies, read the Treasurer's Report. It was particularly noted that there was a general increase in attendance at both shows and clinics which was good for THRC.

#### 7. Appointment of Auditor

Caren McClure was appointed as auditor. Caren had kindly audited the accounts of Tendring Hundred Riding Club.

#### 8. Appointment of Scrutineers

No members came forward to stand for committee, therefore scrutineers were not required.

#### 9. Election of the Committee

- The following committee members, retiring by rotation, had indicated their willingness to stand for re-election:
  - Lorna Simpson
  - Jenna Davies

Re-election for Lorna Simpson was proposed by Nicky Robinson and seconded by Gail Oliver. Re-election for Jenna Davies was proposed by Lilli Hughes and seconded by Nicki Lush. They were duly re-elected.

- b) On the agenda, Carol Chisnell was shown to be up for re-election. However, as Carol is President of THRC, re-election was not required.
- c) A fifteen-minute break was taken after agenda point 12 (see A.O.B) to appoint the Officers for 2020.

  The Chairman, Alison Power; the Honorary Secretary, Angela Bush and The Honorary Treasurer, Jenna Davies had indicated their willingness to continue in their roles.

  Alison Power was proposed as Chairman by Nicky Robinson and seconded by Nicki Lush; Angela Bush was proposed as Honorary Secretary by Lilli Hughes and seconded by Viv Edwards and Jenna Davies was proposed as Honorary Treasurer by Gail Oliver and seconded by Lorna Simpson. They were duly

re-elected.

- last year, was not going to stand as a committee member for 2020.
- e) The Chairman, Alison Power, explained to the members that as the Committee has 12 members with voting rights, no new committee members would be appointed for 2020.

#### 10. Amendments to the Constitution

- Alison Power, Chairman, explained how the Trustee system works for Tendring Hundred Riding Club. Karen Bond, a Trustee for many years, had stepped down so Lorna Chisnell agreed to take on this role.
- 2) Alison Power also explained that British Riding Clubs (BRC) required all affiliated riding clubs to update their constitutions. Tendring Hundred Riding Club have done so. The members were asked if there were any questions regarding this; Gillian Baker asked if all the changes could be explained in greater detail. Alison Power explained the changes as follows:
  - a. Constitution point 3a Membership: this now states having been accepted by the Committee. This gives the Committee the right to decline a membership if necessary.
  - b. Constitution point 3e Our annual subscription year has now changed from October 1<sup>st</sup> to January 1<sup>st</sup> December 31<sup>st</sup>; this is in line with BRC rules
  - c. Constitution point 6 The Annual Subscription is now not stated as it has been previously.
  - d. Constitution point 11 The methods by which we contact members has been changed to include email. Members may still ask to receive items by post if required. Members were also asked to ensure that their email details remain updated.
  - e. Constitution point 14 'All surplus income or profits are to be reinvested in the Club': the word 'reinvested' was added since all profits go back into the Club.
  - f. Constitution point 16 Dissolution: In the event that dissolution of the Club shall occur, the assets of the Club shall be used first to discharge all liabilities of the Club and the remaining assets are to be divided equally between paid up SENIOR members at that time provided that they have been members of the Club for the 4 previous consecutive

years. This wording has been made clearer. If dissolution was to occur, and assets needed to be divided, the Trustees would deal with this. If THRC were to move to new premises, everything would be reinvested into the Club.

There were no further questions.

#### 11. Correspondence

Alison Power read out, former Trustee, Karen Bond's letter of resignation from her role.

#### 12. Any Other Business

- 1) Alison Power, Chairman, explained how teams work in THRC and our role as part of BRC Area 8. The Team Managers, Nicky Robinson (Seniors) and Jo Mason (Juniors) were thanked for their continued hard work with organising teams and supporting THRC members in this capacity. Alison also noted that being in a team can be expensive for members and THRC appreciates the commitment from those members who represent THRC in teams. The levels for teams was explained; it was noted that the Championships are incredibly competitive so potential team members need to be well-established at the level at which they represent the Club. The team managers have a responsibility to ensure that members of a team can compete safely at the required level.
- 2) Alison then read the Senior and Junior Team Reports. She commented upon how lovely it is to see Junior members coming through to Seniors, and the progress that they make. All team reports are available on the THRC website.
- Angela Bush, Honorary Secretary, explained the new online membership system. It was hoped that everyone would embrace it in the era of sustainability and that it would make tracking membership much easier.
- Angela encouraged members to fill in the feedback forms distributed around the hall in order to help inform our future planning.
- 5) A bouquet of flowers was presented to Alison Power by Angela on behalf of the THRC Committee for all her hard work as Chairman this year.

#### 13. Chairman's closing remarks

Alison Power thanked all the members for attending the AGM again. The dedication of the THRC Committee was noted; both the Chairman and Committee look forward to seeing the Club go from strength to strength in the coming year.

## THRC Team Review 2019

Area 8 only consists of six clubs - Tendring Hundred RC, Saffron Walden, Billericay, Stansted, Ingatestone & Blackmore and Essendon & Epping Dressage Group but, between us and with a very efficient Area committee, we organise seven area competitions – Eventer Trial, Show Jumping, Dressage, Horse Trials, Winter Dressage & Combined Training, Arena Eventing and Winter Show Jumping. These area events qualify for six different British Riding Clubs National Championships around the country.

Senior Teams Twenty-six seniors from THRC have competed for the club with some great results at all these Area events. We always seem to come away with good results and a group of them qualified for the National Championships at Lincoln in September.

Emilia Hunnaball

qualified for dressage at the Winter Intermediate Dressage champs and came 6th as an individual.



Jess Joslin qualified in the show jumping as an individual at Wix Equestrian centre for the BRC Intermediate Winter Championships held at Bury Farm. They were very successful, proudly representing THRC coming 2nd out of 102 horses!

Junior Teams The Junior teams have done extremely well at the Championships this year.



Sarah Endean took part in her final Junior National Championship at the BRC Novice Winter Championships competing in the 80 cm show jumping. Sarah

Chloe Mason also attended the Winter Novice Championships at Arena UK in March where she came 2<sup>nd</sup> as an individual

in her novice dressage class.

came 2<sup>nd</sup> with Lucy and Alanna 2<sup>nd</sup> and 4<sup>th</sup> individually at the Championships at Aston Le Walls. The same girls then won the Horse Trials qualifier and came 2nd at the championships at Swalcliffe with Chloe winning her arena, overall 2<sup>nd</sup> individually and 1<sup>st</sup> non BE award; Lucy and Alanna came 2<sup>nd</sup> and 9<sup>th</sup> in their arena.

The four girls then went to National Championships jumping 90 cm having won the qualifier again; Chloe was individually 11th out of 70+ riders. The girls also rode in the team of four dressage where you have to follow each other to a set routine; they were placed 2<sup>nd</sup> out of 5 teams and Chloe was also placed 7<sup>th</sup> in the Novice Dressage riding Corine.

Fern Morris was invited to make up an Area 8 team with Billericay Riding club at the 70 cm show jumping where the team came 2nd.





Chloe and Lucy also won the Dressage to Music pairs championship at Bury Farm with Chloe being placed 6th in her Novice music class.

Other Junior riders have done very well at this year's qualifiers with lots of placings and some new combinations coming

forward to represent the club at the lower levels, which is lovely to see. Special thanks must go to the parents for transporting both the ponies and children to the different venues, both locally and nationally.

### Tendring Hundred Riding Club Constitution and Rules

#### 1. TITLE

The Club shall be known as the 'Tendring Hundred Riding Club'.

#### 2. OBJECTS

The objects of the Club shall be:

- (a) To encourage riding as a sport and recreation, to promote good fellowship amongst riders and to improve and maintain the standard of riding and horsemanship.
- (b) To organise instructional meetings, lectures and competitive events and other activities to further the objects.
- (c) To be affiliated to The British Horse Society and to support and co-operate with recognised organisations interested in the breeding and use of all breeds and types of horses and ponies.
- (d) To investigate the subject of bridle tracks and rights of way with a view to opposing those that have been closed and maintaining and more clearly defining those that are in existence.
- (e) To concern itself with any object which will benefit the horse and horse user in the district.

#### 3. MEMBERSHIP

- (a) This shall consist of persons who have attained the age of 18 years (and persons aged 17 years and under if a junior section is formed) and, having been accepted by the Committee, have paid the due subscription for the current period.
- (b) Honorary membership may be conferred by the Committee upon any person deemed by them to have rendered notable service to the Club.
- (c) No junior member may be a voting member of any Riding Club. However, Clubs with a junior membership may appoint a Junior Committee to discuss matters relevant to the junior membership. This Committee, through the Chairman of said Committee, may make recommendations to the Adult Committee for their consideration.
- (d) A member shall complete the application form as prescribed by the committee. Membership of the Club shall be open to anyone interested in the sport on application regardless of sex, age, disability, ethnicity, nationality, sexual orientation, religion or other beliefs. The committee may refuse membership only for good cause, such as conduct or character likely to bring the Club or the sport into disrepute. Appeal against refusal may be made to the members. However, limitation of membership according to available facilities is allowable on a non-discriminatory basis.
- (e) The annual subscription shall be payable on October 1st. Any member whose subscription is not paid by the end of February shall have his or her name removed from the Membership List after written notice to the effect has been sent to him or her. Any member joining the club on or after September 1<sup>st</sup> shall be deemed to have paid his or her subscription for the ensuing year.
- (f) The Committee may expel (or temporarily suspend) from membership of the Club any member who, or in the case of a junior member whose parent, has breached any of the rules of the Club, or who has in the opinion of the Committee have been guilty of any conduct derogatory to the character or prejudicial to the interest of the Club, provided that before expelling him or her the Committee shall allow the member to appeal the decision to the members and provide an explanation of his/her conduct and allow a proper opportunity of answering the allegations against him/her.

#### 4. ADMINISTRATION

#### The Committee

- (a) All powers of management shall be vested in the adult Committee consisting of the Chairman, Honorary Secretary, Honorary Treasurer and at least 8 other Committee Members; 9 shall form a quorum.
- (b) At the Annual General Meeting each year, 3 of the members of the Committee shall retire, the members to retire being those who have been longest in office. Those who have been in office for the same length of time shall determine retiring members by lot. Retiring members shall be eligible for re-election.
- (c) The Chairman, Honorary Secretary and Honorary Treasurer shall be elected annually by the Committee from amongst their number.
- (d) The decision of the Committee shall be final unless over-ruled at a General Meeting.
- (e) The Committee shall be the sole authority for the interpretation of the rules and for anything relating to the club not provided therein and their decision shall be final and binding on the members.
- (f) The Committee may formulate byelaws for the detailed running of the Club and elect sub committees for any special activities of the Club which the Committee may authorise.
- (g) The Committee shall have the power to fill any casual vacancy arising amongst members of the Committee, but any person so co-opted shall retain office only until the next following Annual General Meeting and then shall be eligible for re-election
- (h) A member seeking election to the committee must have paid a subscription to the Tendring Hundred Riding Club for the previous year.
- 5. The financial year of the Club shall commence on October 1st each year.
- 6. The annual subscription shall be £25 for seniors and non-riders and £20 for juniors or such other sum as shall from time to time be determined by the Committee. The Club will keep subscriptions at levels that will not pose a significant obstacle to people participating.

- 7. The Committee may appoint annually a President and Vice-Presidents. They shall not by virtue only of such appointment become members of the Committee.
- 8. The Annual General Meeting shall be held in November of each year to transact the following business:
  - (a) To receive and, if approved, to adopt a Statement of the Club's Accounts to the end of the preceding year.
  - (b) To fill vacancies on the Committee
  - (c) To appoint an Auditor
  - (d) To deal with any special matter which the Committee may desire to bring to the members and to receive suggestions from the members for consideration by the Committee. Notice convening the General Meeting shall be sent to the members not less than 10 days before the meeting and shall specify the matters to be dealt with.
- 9. A Special General Meeting may be called by the Committee, or by a request signed by not less than 10 members specifying the business to be discussed. The Secretary shall give all members 10 days' notice of the date of such a meeting and shall specify in such notice matters to be dealt with at the meeting.
- 10. The Accounts of the Club shall be audited or verified each year by the person appointed at the previous Annual General Meeting. Accounts must be audited or verified by an independent professional.
- 11. Notice may be given to any member by sending it by post (or email) to said member at their address in the United Kingdom registered in the records of the Club. If any member has no address in the United Kingdom such member shall not be entitled to receive any notice. The accidental omission to give notice of a meeting to or the non-receipt of a notice of a meeting by any member shall not invalidate the proceedings of the meeting.
- 12. These rules may be added to, repealed or amended by resolution at any Annual or Special General Meeting, provided that no such resolution, shall be deemed to have been passed, unless carried by a majority of at least two-thirds of the members present and voting thereon and provided that prior notice has been sent to all members stating the proposed amendment.
- 13. Members shall be correctly turned out at all Club events. Any protective clothing required by current British Riding Clubs rules must be worn. (See current BRC Rulebook)
- 14. All surplus income or profits are to be reinvested in the Club. No surpluses or assets will be distributed to members or third parties.

#### **15. TEAMS**

- (a) Any member chosen for Team events will be responsible for their own travelling expenses, transporting their own horses and for entry fees, unless the committee decide that these expenses shall be covered by club funds. Competitors must be fully conversant with the BRC Affiliated Rule Book and abide by them.
- (b) Any member accepting a place in a team representing the club in a qualifying team who does not keep themselves and their horse available for the finals, unless due to injury or ill health of horse or rider, will be liable to reimburse the Club for all expenses incurred by the Club.

#### **16. DISSOLUTION**

In the event that dissolution of the Club shall occur, the assets of the Club shall be used first to discharge all liabilities of the Club and the remaining assets are to be divided equally between paid up SENIOR members at that time provided that they have been members of the Club for the 4 previous consecutive years.

#### **17. THE PROPERTY**

The property of the Club shall be vested in 4 Trustees who shall be appointed by the Committee and the property of the club shall be vested in them to be dealt with by them as the Committee may from time to time direct by resolution (of which an entry into the minute book shall be conclusive evidence); the Trustees shall be indemnified against risk and expense out of the Club property. The Club Trustees shall hold office until death or resignation or removal from office by the Committee. Whereby reason of such death, resignation or removal it is necessary that a new Trustee or Trustees be appointed, the Committee shall nominate the person or persons to be appointed the new Trustee or Trustees. For the purpose of giving effect to such nomination, the Chairman is hereby nominated as the person to appoint new Trustees of the Club within the meaning of Section 36 of The Trustees Act 1925 and shall by deed duly appoint the person or persons nominated by the Committee.

18. If, at any time the Club in general meeting shall pass a resolution authorising the Committee to borrow money, the Committee shall thereupon be empowered to borrow for the purposes of the Club such amount of money either at one time or from time to time and at the rate of interest and in such form or manner and upon security as shall be specified in such resolution and thereupon the Trustees at the direction of the Committee may deem proper for giving security for such loans and interest. All members of such resolution shall be deemed to have assented to same as if in favour of such resolution.
